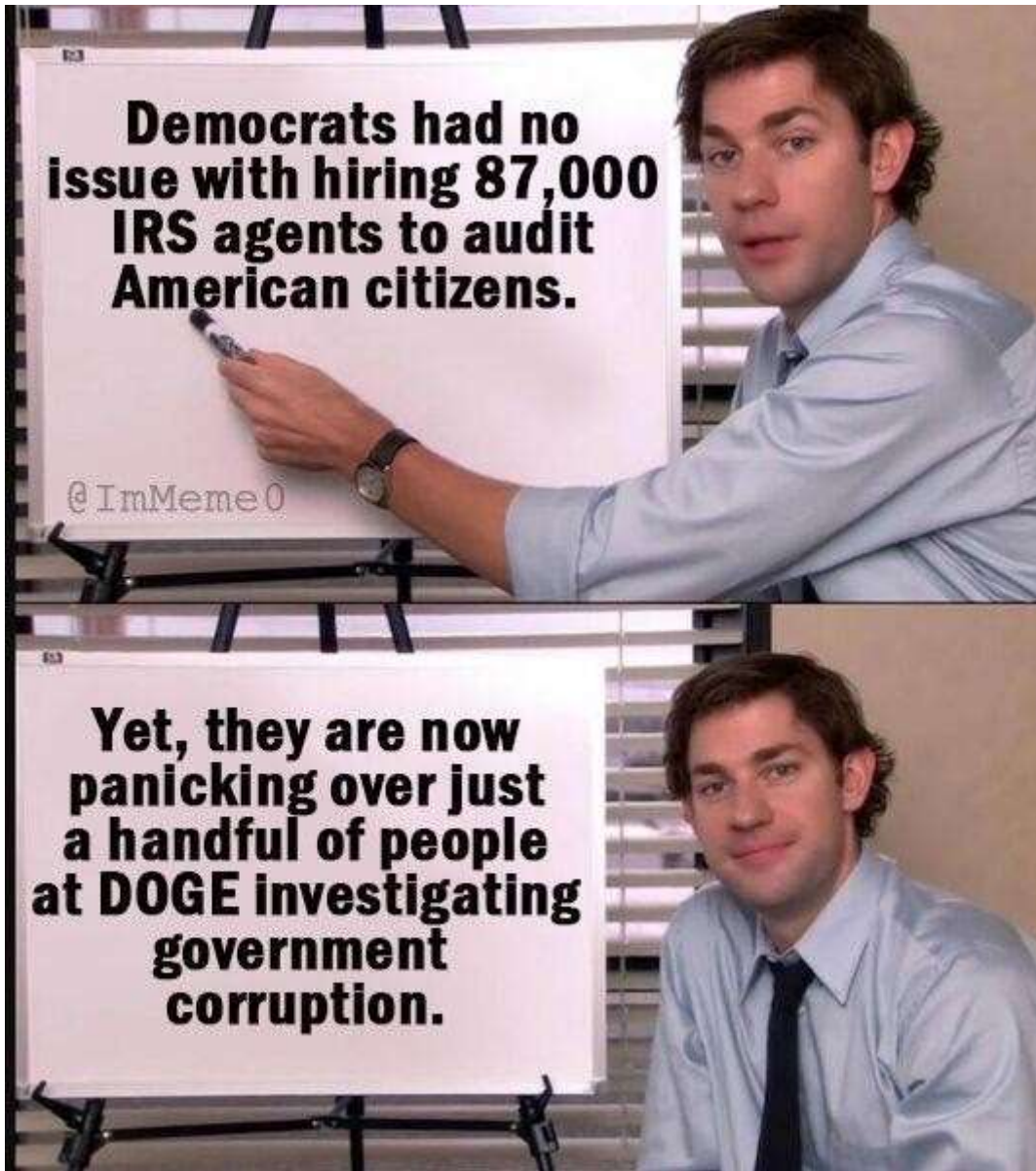

U.S. SIGNS LOAN GUARANTEE AGREEMENT FOR UKRAINE

KYIV, Ukraine - The United States today reaffirmed its strong commitment to the people of Ukraine by signing a \$1 billion sovereign loan guarantee agreement with the Government of Ukraine. The guarantee will help the Government of Ukraine continue to institute reforms that tackle corruption, improve the business climate, put the economy on a sustainable path to growth, and make government more responsive to the people.

"The \$1 billion loan guarantee will help the Government of Ukraine to carry out its ambitious economic reform agenda," said USAID Acting Administrator Alfonso Lenhardt. "The guarantee sends a strong signal of U.S. support for Ukraine in achieving its reform goals and fulfilling the Ukrainian people's aspirations for a prosperous and democratic future."

The U.S. loan guarantee is part of a comprehensive international financial package, involving both official and private sectors, designed to support Ukraine as it puts in place a reform program. When issued, the U.S. loan guarantee will provide the Government of Ukraine with access to affordable financing from international capital markets, enabling the Government of Ukraine to provide critical services and protect the most vulnerable Ukrainians from the impact of necessary economic adjustments as it implements key reforms.

Ukraine Minister of Finance Natalie Jaresko, U.S. Ambassador to Ukraine Geoffrey Pyatt, and U.S. Agency for International Development (USAID) Ukraine Mission Director E. Jed Barton participated in the signing ceremony in Kyiv, Ukraine.

The United States provided Ukraine with a \$1 billion loan guarantee in May 2014. If Ukraine continues making concrete progress on its economic reform agenda and conditions warrant, the Administration has indicated it would be willing, working with Congress, to consider providing up to an additional \$1 billion loan guarantee in late 2015, for a total potential contribution of up to \$2 billion in guarantees in 2015.

This news release on the website of USAID admits to sending \$1 billion to Ukraine. Should the US government be giving foreign countries money when the US has an open border crisis, drug crisis, homeless crisis, inflation crisis, crime crisis, and debt crisis? Because Ukraine is not a democratic government (the president cancelled elections to keep himself in power), why should the US pay for their security when the US already has a security crisis at the border?

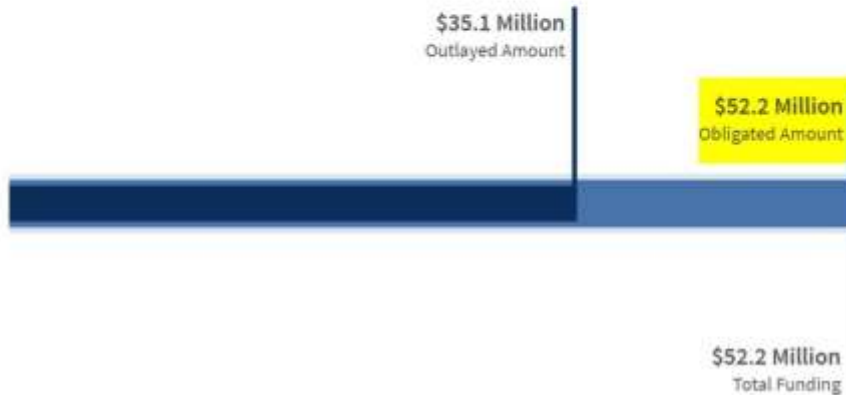



USAID Funding Reddit Censorship

USAID identified three kinds of information that it wished to combat:

1. Misinformation
2. Disinformation
3. "Malinformation" is apparently also a 'serious threat'. USAID defines malinformation as speech that is factually correct but has been deemed misleading or taken out of context.

Under this broad definition, any reporting or arguments, no matter their accuracy, could potentially be throttled online if it is deemed unhelpful or inconvenient to USAID and its interests.

To address the spread of "malinformation," USAID has increasingly focused on restricting independent media and open platforms where alternative viewpoints and information are shared.

They identified platforms such as Reddit, Discord, and 4Chan as "conspiracy websites" that enable groups to foster "populist expertise," allowing for the creation of alternative viewpoints that contest official U.S. government narratives. These platforms, along with gaming sites, are seen as needing to be confronted and marginalized.

As of now, it seems Reddit has run amuck with censorship and Trump / Elon hate speech. This should not be a surprise as this was ultimately the original intention of USAID.

B. UNDERSTANDING ALTERNATIVE MEDIA SPACES

Discussions on disinformation and misinformation often revolve around assumptions of state actors driving the issue. However, problematic information more regularly originates from networks of alternative sites and anonymous individuals who have created their own "alt-media" online spaces.¹⁴⁹ These alternative spaces include message board and digital

distribution platforms (e.g., Reddit, 4chan, or Discord); conspiracy news sites (e.g., RT and 21st Century Wire); and gaming sites. According to Eliot Higgins, founder of Bellingcat, the alternative media ecosystem has become a prominent driver of disinformation, yet not many organizations, journalists, or researchers are engaged in this topic.¹⁵⁰ This present failure to address alternative media systems threatens and undermines other efforts to counter disinformation.¹⁵¹

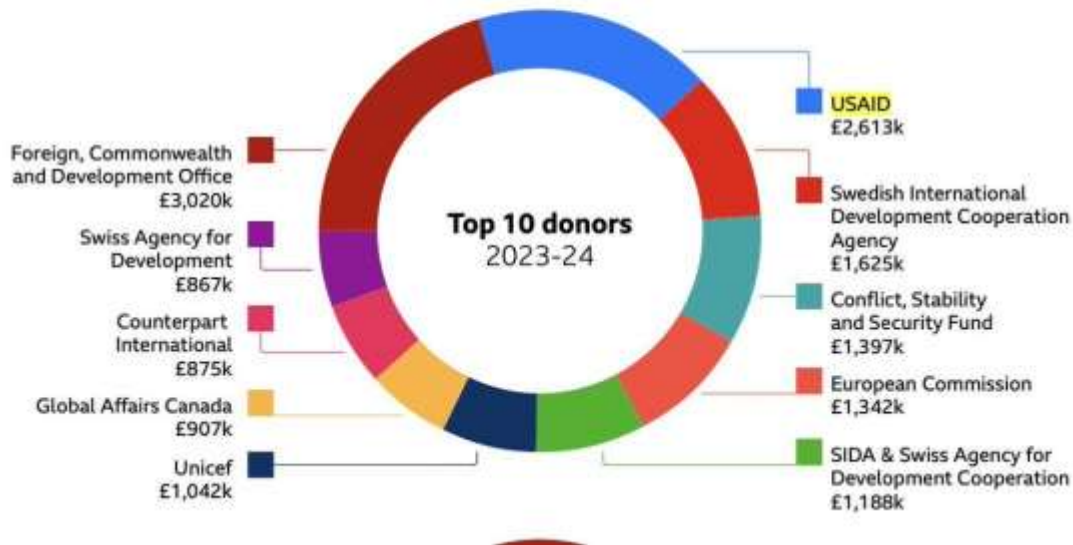
OUR FUNDING

BBC Media Action's global team continues to deliver impact around the world amid constant change.

Fundraising remains challenging in an environment of shrinking overseas development aid. Consequently, in the second half of 2023–24, BBC Media Action made improving our financial health a major organisational priority. Our response plan, approved by our trustees in May 2024, includes investment in building our sources of unrestricted funding and exploring more flexible sources of funding from our largest donors.

We are grateful to all our donors who make our work possible. Together, our donors funded our work to the value of £25.2m (£27.1m in 2022–23). As of 31 March 2024, we had 107 (2023: 120) active projects around the world.

Institutional funders remain our largest source of support. In 2023–24, our main donors included the UK FCDO, **USAID** and Sida, among many others.
