



Part 1: What is the Truth about January 6?

1. What happened on January 6, 2021 at the US Capitol building?
2. Was it a protest, a march, a riot, an attack, an insurrection, political theater, neither, or what word best describes what transpired?
3. Is it true that people were hurt or killed?
4. Why did people gather in the first place?
5. Why is it so prominent in the main stream media while similar events are not?
6. Has political propaganda influenced the perceptions of US citizens?
7. What is the truth?

This document will introduce the topic through information from social media sources that appear less-biased than main stream media, then will link to a 45 minute video and additional resources.

Defining Terms

What is an “insurrection”?

Merriam-Webster: “an act or instance of revolting against civil authority or an established government”

This definition appears to be unchanged since at least 2006 or earlier.

What is “revolting”?

Merriam-Webster: “to renounce allegiance or subjection (as to a government) :” “to experience disgust or shock” “a renouncing of allegiance (as to a government or party)” “a movement or expression of vigorous dissent”

Is it true that attendees of January 6 actually “revolted”? Maybe some did, and some didn’t. It is likely that not everyone attending was there for the same reasons. The attendees included conservatives, independents, leftists, Antifa, some pretending to be Trump supporters with MAGA hats, media, FBI, police, security, adults, children, and perhaps some just attending because their friends were, or perhaps just sight-seeing. It would seem dishonest to characterize all people in a particular space to be 100% of one people-group with one united motive.

The mainstream media has consistently characterized attendees of this event as being “bad” while failing to account for the diversity of people in attendance and for different motives. Was the media also bad for attending and should they be in jail? Were children bad for attending and should they be imprisoned? This narrow-viewed reporting should arouse suspicion and should be questioned. Given that past protests near the capitol were whitewashed and not so vigorously covered by this same media, even more questions must be asked. Why would it do that? Is it possible that the left-leaning media has a bias against conservatives by condoning the frequent leftist protests while hugely covering in a negative light a more rare conservative protest?

Is a "mini revolution" similar to an "insurrection?"

What is the truth about the deaths from January 6? Is it true that 5 people died as the left media claims?

Conservative attendees didn't appear to kill anyone on January 6. It appears that Capitol police killed 2 conservatives, however. One was Ashli Babbitt, an Air Force veteran, shot in the head by Michael Byrd, a black Capitol Police officer. He was never arrested for the unnecessary murder. In his defense, the large black man claimed he was "very afraid" of the small, unarmed white woman. It appears the Justice Department never pursued this case and they only had an "internal probe" where he was promptly released of all charges.

Roseanne Boyland was reportedly killed by Capitol Police officer Lila Morris. A horrifying video shows her being repeatedly beaten and possibly trampled as police created a panic by spraying pepper spray on people.

The main stream media mostly mitigated covering the conservative deaths, but counted people who died later (not at the protest) as caused by January 6th, perhaps to inflate the numbers and to make it seem like conservatives were more violent than they actually were. Among these was a police officer who received pepper spray to the eyes. He died that evening. Others had heart attacks.

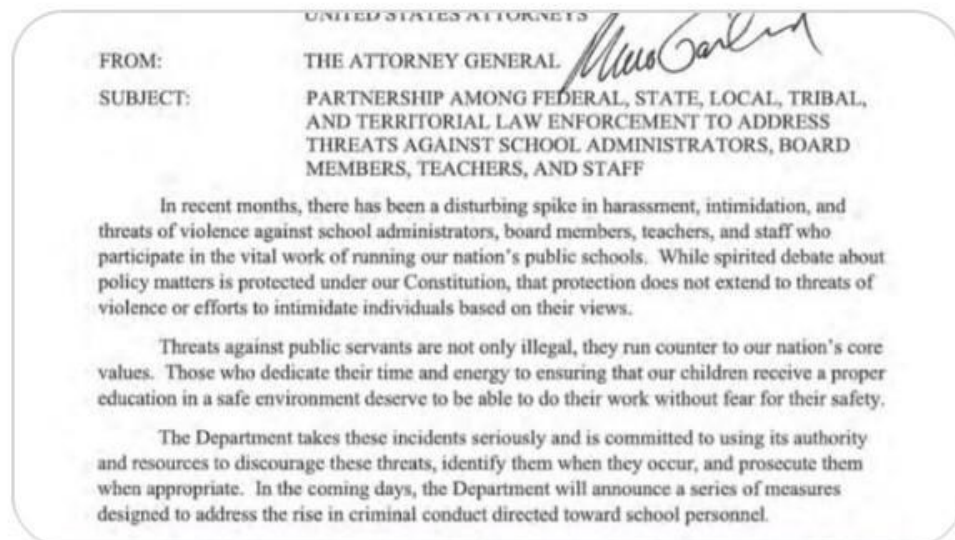



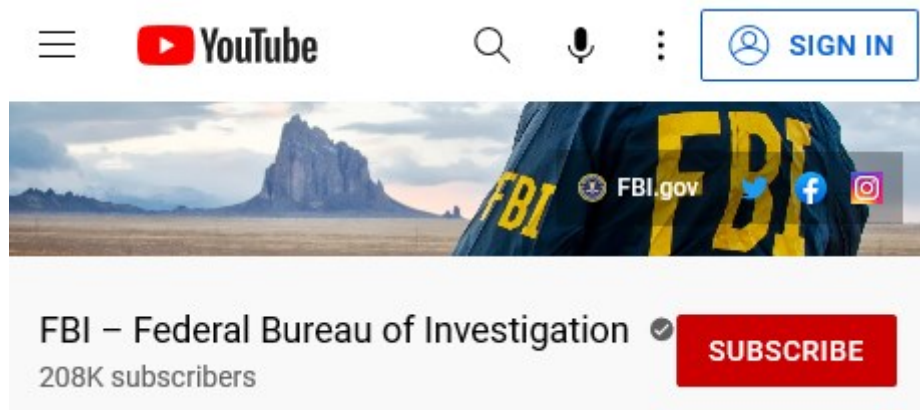

At Hemphill's sentencing hearing Tuesday, Senior U.S. District Judge **Royce Lamberth** cut right to the point, telling Hemphill that she will be serving time behind bars.

"As tempting as it is to be lenient in this kind of situation, what I have discerned is it is such a serious offense because it's such a serious event in the history of our country," Lamberth said. "I have to agree with the government's recommendation in this case. I believe that there has to be a penalty when there is a serious offense like this."



The FBI posts videos of its suspects (or opponents) to YouTube. It has posted dozens of videos from January 6th to its page, but no videos could be found from them of the hundreds of daily riots by Antifa and BLM that previously occurred across the country. Violence flares in Washington during Trump inauguration

WASHINGTON (Reuters) - Black-clad activists among hundreds of demonstrators protesting Donald Trump's swearing-in on Friday clashed with police a few blocks from the White House, in an outburst of violence rare for an inauguration.

It appears that leftist protesters in Washington committed violence and hundreds were arrested on the day when Trump was inaugurated in addition many other riots and protests. They apparently were upset about his election, and took over the streets in Washington, but this wasn't called an "insurrection" or even a "riot" by the leftist media.

Why did people gather on January 6?

Americans thought the 2020 election seemed suspicious and possibly unfair. They wanted it investigated, but the politicians resisted and signed off quickly on the outcome, seeking to ignore it and move on. Many thought this seemed like people had something to hide and deserved more analysis before a new president was installed.

Voters planned to protest in Washington DC on January 6, but this also presented an opportunity for any number of other groups with other negative political objectives to also attend. Conservatives showed up peacefully and unarmed, listened to some speakers, voiced their constitutionally protected rights and most went home. Most attendees seemed unaware of mayhem that bad actors started near some entrances of the Capitol building and that the FBI and Antifa appeared to be involved. It is reported that the Capitol was first entered during Trump's speech, but that the area where Trump spoke was not near the Capitol, but up to a 45 minute walk away. There appears to be no evidence these two events are correlated. When Trump later heard about things escalating, he Tweeted out for everyone to be peaceful. He also asked everyone to go home in a video sent via Twitter. The media tries hard to make this event sound like a hostile takeover or siege and likes to use the word "insurrection" but if that was the true intention would it be normal for protestors to show up unarmed then go home when they learn what happened? And would it be normal for a hostile takeover for the President to ask for increased security, to condemn violence, and ask everyone to remain peaceful and to go home?

If all some people did is stand outside the Capitol building on January 6, why are they held in jail without trial?

The justice department appears to be politically motivated and there is no clear answer for why in a free country where people are supposed to be presumed innocent until proven guilty that people would be presumed guilty of trespassing when they may have either been welcomed into the building by police while it was technically "closed" or else may not have entered the building at all.

Why were most police peaceful and welcoming of protesting visitors, while others were not with tear gas and flash bangs used against protestors?

The answer to this is unclear. The capitol police apparently had mixed messages about what they were to do. There likely was confusion about who was peaceful and who was a paid agitator, such as by FBI or Antifa as these actors blended in. Maybe protestors near one wing of the Capitol were more unruly than the other areas? Naturally, the main stream media zeroed in only on the small area where people scuffled the most, maybe to paint a picture as if the whole event was that way.

Main stream media sometimes get their narrative mixed up. The article on the left appears to admit that Trump requested extra national guard troops for January 6, but that the request was not fulfilled. The article on the right appears to deny that. A leftist “fact check” website made the same claim that it was “false” that Trump requested it, because they had “no evidence” of it. The “fact check” website regularly claims things are false simply because they don’t have the evidence in front of them confirming it. It is also unconfirmed if they did any research on the subject, but is confirmed they have political bias.

Is it normal for someone who wants to commit an “insurrection” or an “attack” to request extra security in defense of that? Does it sound rational that an “attack” was planned using unarmed people against armed police and security? Is it possible that the left is using inflammatory language to make this event seem more dramatic than what it really was? Mass shootings in democrat-run cities like Chicago are in a crisis with hundreds dying nearly every weekend, but while congress seems to ignore this crisis they seem to have time for multiple hearings on January 6 where police killed 2 protestors. 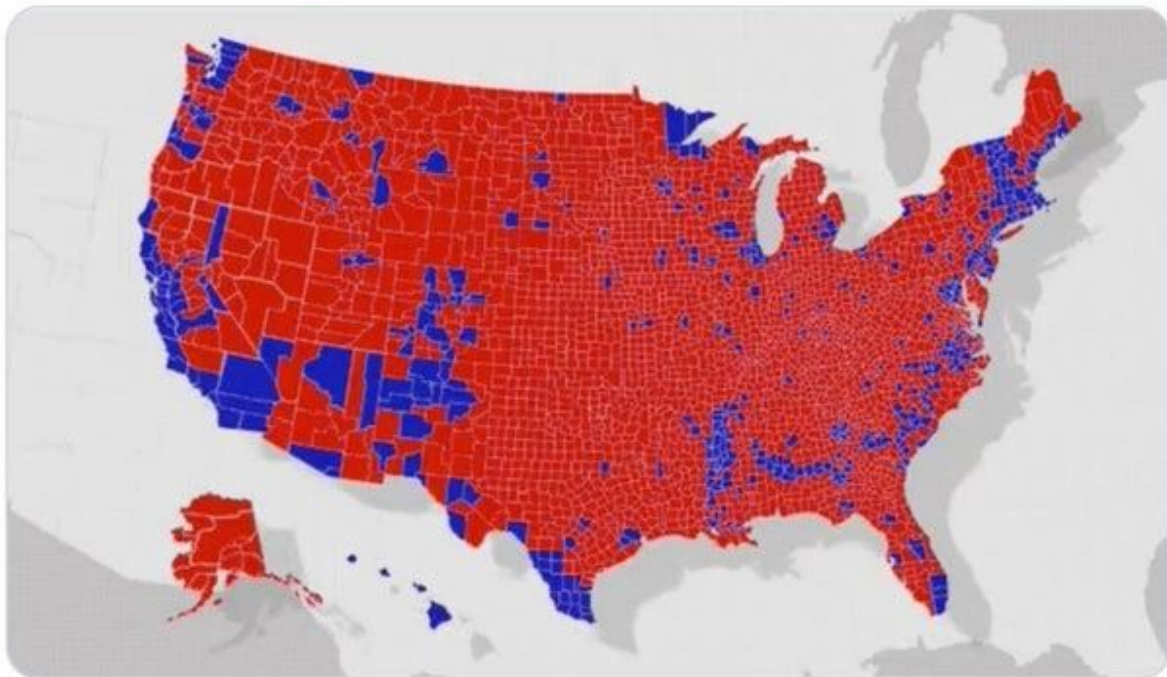

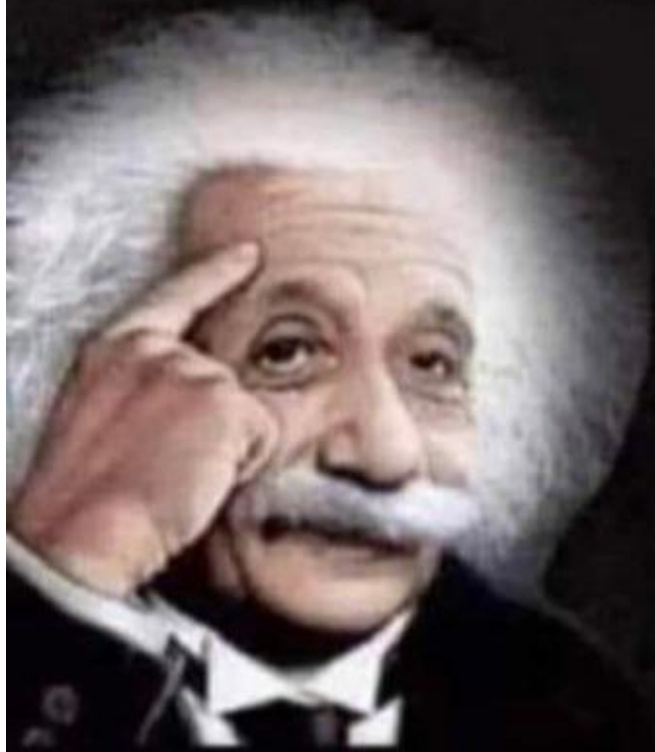

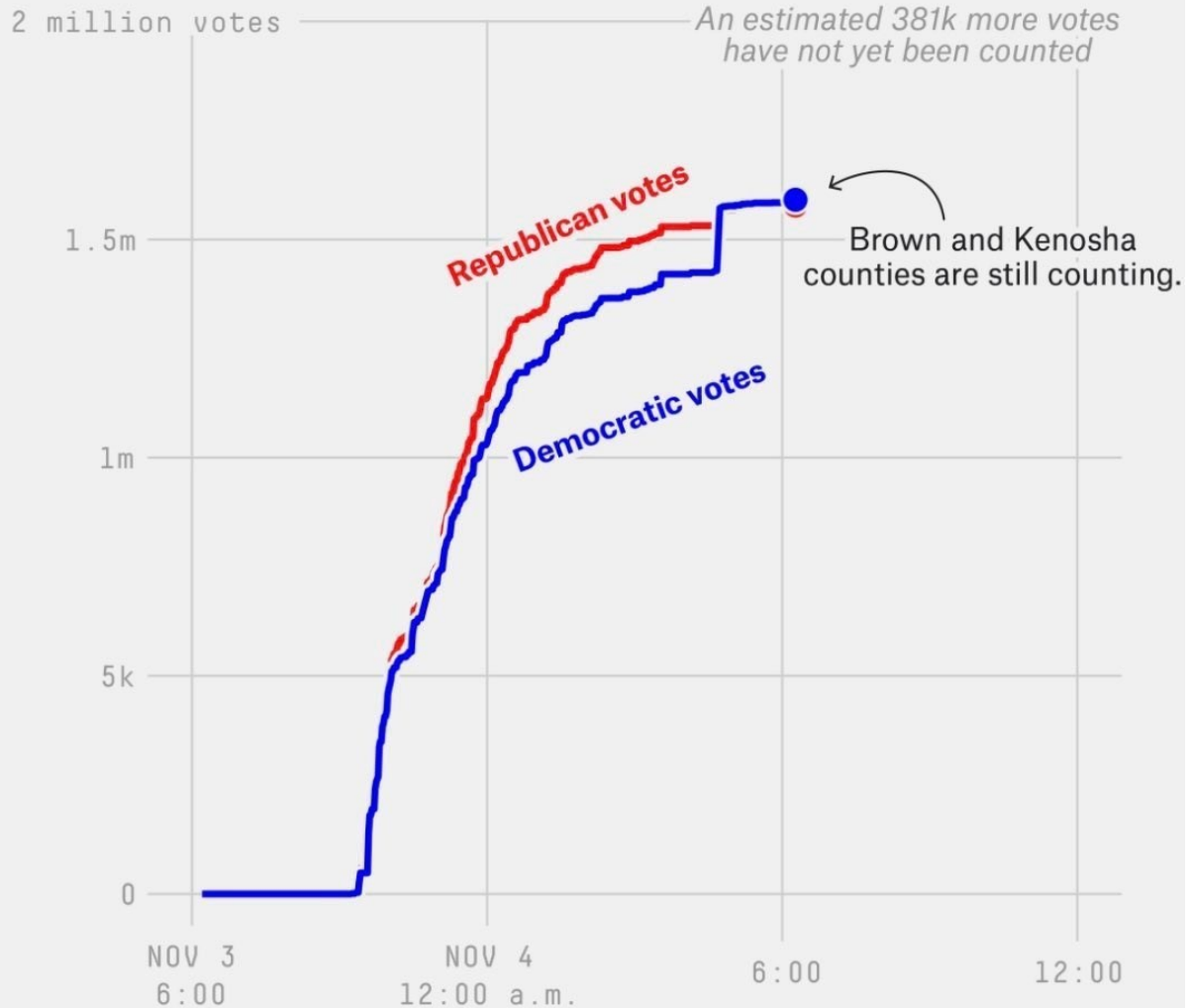

Dominion Voting Systems and Venezuela

Powell claimed that widely used voting machines from the election technology company Dominion Voting Systems featured software created "at the direction" of former Venezuelan President Hugo Chavez to swing his own election results, and that the company has ties to the Clinton Foundation and Soros.

Facts first: None of this is true. Dominion has no corporate ties with Venezuela, the Clinton Foundation or Soros.

Powell and other Trump allies have tried to tie Dominion, which sells election technology that was used in more than two dozen states, to another voting company called Smartmatic. During the 2020 election, Smartmatic's technology was used only in Los Angeles County, and not in any swing states, a spokesperson for the company told CNN.

Smartmatic was founded in Florida by two Venezuelans, and did provide election technology to the Venezuelan government. Powell has posted on social media a purported affidavit from an unnamed Venezuelan official claiming Smartmatic software was used to change votes in the country. But those claims have no evidence, and there's no reason to believe the company's software was created to make sure Chavez "never lost an election," as Powell claimed. The company [actually spoke out](#) to accuse the Venezuelan government of voter fraud in 2017.

The bigger issue with this claim is that there is no evidence that Dominion machines used Smartmatic software, as Powell suggested -- and thus zero connection between Venezuela and the company whose voting machines were actually used in the swing states Trump is focusing on. Both Dominion and Smartmatic have said that they are competitors with no corporate links.

The origin of the claim linking the companies seems to be a convoluted corporate transfer: In 2005, Smartmatic acquired a company called Sequoia Voting Systems, but [sold it](#) in 2007 after questions from members of Congress over the acquisition by a company linked to Venezuela. Three years later, Dominion, which was founded as a Canadian company but is now majority owned by Americans, acquired Sequoia. In addition, Smartmatic licensed Dominion machines for use in the Philippines in 2009, but the contract ended in a lawsuit, Dominion [said in its statement](#).

Neither Dominion nor Smartmatic have corporate ties to the Clintons or Soros, a major Democratic donor. While Dominion did agree to donate its technology to "emerging democracies" as part of a program run by the Clinton Foundation in 2014, according to [the foundation's website](#), Dominion said in its statement that it has "no company ownership relationships" with the foundation. And while the chairman of the board of Smartmatic's parent company is also on the board of a foundation run by Soros, Open Society Foundations, Soros himself is not involved in either company.

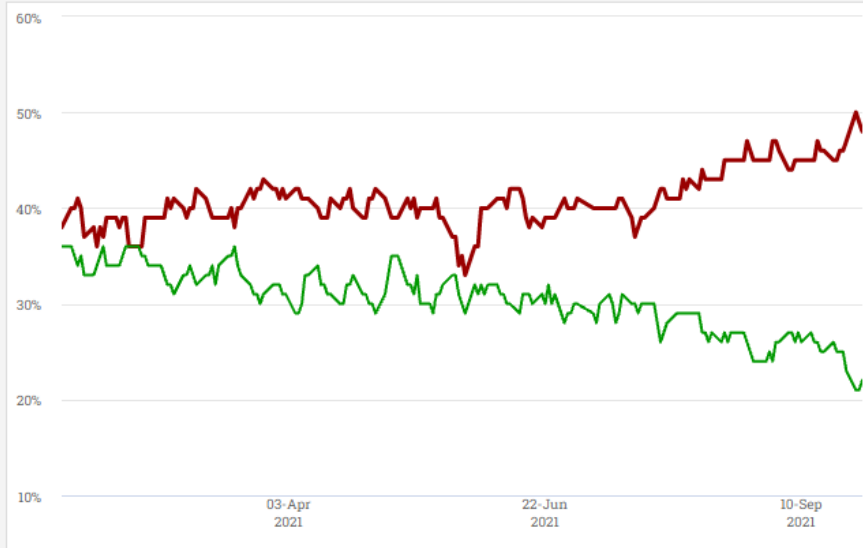
